- All teams are guaranteed two games if the tournament is full, three games if tournament is run with 12 teams.
- All players must attend the same school or be on a recreation roster team all year. No AAU or All-Star teams will be allowed.
- Games will be played following WIAA rules with WIAA officials.
- Three point contest (two entrants per team with individual and team awards) - 7th/8th grade only.
- Free throw contest (two entrants per team with individual and team awards).
- Team trophies for 1st through 5th place in the championship bracket.
- Team trophies for 1st and 2nd in the consolation bracket.
- Individual trophies for 1st and 2nd place in the championship bracket (15 per team).
- Individual awards for All-Tournament Team Selections (9).
- Sportsmanship award (based on players, coaches, and fan conduct throughout the tournament).
- Tournament MVP award.
- Concessions will be available.
- **Entry fee of \$125 payable to Christ Child Academy Athletics. 7th/8th grade due by December 31, 2009, 5th/6th due by January 31, 2010 along with Tournament Entry Form.**
